5. DETAILS OF ARTICLES OR LAND INVOLVED IN THE CASE
6. ROUGH SKETCH IN THE CASE OF LAND(RIGHT SIDE TOPMOST CORNER)
7. NAME OF OFFICERS INVOLVED IN ACTION WITH SIGNATURE
8. LIST OF WITNESS WITH SIGNATURE(MINIMUM 2)
9. PLACE AND DATE
