**ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, sanction has been accorded for the establishment of Revenue Institute at P.T.P, Nagar. The Institute was set up as an autonomous Institute namely State Institute of Revenue Administration, Kerala registering the same under Travancore, Cochin literary, scientific and Charitable Societies Registration Act. Government have approved the Rules and Memorandum of Association of the Institute as per the Government Order read as 2<sup>nd</sup> paper above.

2. As per the rules and memorandum, the Institute is known as State Revenue Training Institute. Even though, as per the Memorandum of Association and Rules, name of the Institute is Revenue Training Institute, from 1995 onwards, it is being called as "Institute of Land Management" without formal Amendment to rules. The decision to rename the Institute was taken in the meeting of the Governing Body of the State Revenue Training Institute held on 16.6.95. Though decision was taken by the Governing Body, to rename the Institute as "Institute of Land Management".

Government have not amended the rules in this regard. The Director of the Institute has therefore proposed to issue orders to give affect to the resolution of the Governing Body as per his letter as 3<sup>rd</sup> paper above.

3. The Commissioner for Land Revenue has in his letter read as 4<sup>th</sup> paper above, proposed to amend the provisions under Rules 6 and 10 of the Rules of the Institute so as to reconstitute the Governing Body and Executive Committee of the Institute as follows,

5. In the circumstances, Government are pleased to order that the State Institute of Revenue Administration will be renamed as "Institute of Land Management". Government are also pleased to amend Rules 6 and 10 of the Rules of Institute as suggested by the Commissioner for Land Revenue reconstituting the Governing Body and Executive Committee of the Institute as follows,
